Recommendation: The project is not likely to create significant adverse impacts upon the environment. It is recommended that a negative declaration is issued for this project.





Description:

To fill in the Inner Loop from S. Clinton Avenue to E. Main Street,

approximately 24.6 acres along the southern portion of the loop changing it from a 10-12 lane section to a 3-5 lane "complete Street" incorporating balanced pedestrian, bicycle and vehicle needs, and creating development

parcels.

At their November 21, 2013 meeting, the Rochester Environmental Commission reviewed the information provided to them. They were generally in support of the concept of the project and its benefits to the city and the region. Based on a lack of information, the Commission recommended a Positive Declaration (Jonientz, Pospula, Zwahlen, Kuckman-yes; McMullen-no; Robertson-absent).

At their December 19, 2013 meeting, a presentation was given by the City of Rochester. The Commission determined that the presentation and opportunity for questions and answers adequately addressed all of their concerns. A motion was made by Kuckman, seconded by McMullen, to rescind the Positive Declaration. By a vote of 4-0-1 (Jonientz, Pospula, Kuckman, McMullen-yes) (Robertson-abstain), the recommendation for a Positive Declaration was rescinded.

Description:

To demolish and remediate the Rochester Gas and Electric BeeBee Station Main Plant, an electric generation and transmission facility encompassing approximately 18.3 acres, located northeast of the center city on the western bank of the Genesee River in the High Falls/Brown's Race area. The scope of work includes complete structure decontamination (asbestos, lead based paint, etc.) and demolition of the multi-story BeeBee Station Main Plant, Station No. 3 office building, various sheds and small outbuildings, approximately 330,000 square feet; shale rock cliff stabilization; removal of above and below ground utilities no longer required for site operations, maintenance and security; and, selective site restoration to a vegetated state. No redevelopment is proposed.

Recommendation: The project is not likely to create significant adverse impacts upon the environment. It is recommended that a negative declaration is issued for this project.
