


COMMENTS: Regarding: Cross walk stripe ^(at cross at) between 481 + 478 Thurston: See sketch at Bottom
I am grateful for the opportunity to suggest a cross walk marking be made on Thurston Road at ^{main} entrance of 481 Thurston Rd and the church, 500 Thurston Rd. + 478 Thurston Rd.

- 1) At times one has to wait along time to cross. It seems some cars ^{even} speed up when they see someone trying to cross.
- 2) There being no lights for a long distance (Brooks to Anthony - 9 or 10 streets) the traffic moves too fast for the elderly or disabled to cross safely.
- 3) When it is busy one can wait a long time to cross ^{even} when able to move swiftly.
- 4) During winter, especially, the neighbors ^{often} cross at that point because it is shoveled.

Also, ^(moving) going from W. Sawyer Pl. on to Thurston Rd is often unsafe when we can't see around vehicles parked too close to W. Sawyer Pl. There have been numerous accidents at that corner. Is there some way to build the curb out for about 12' like this?
