PERMIT FEES FOR WORK WITHIN THE CITY PUBLIC RIGHT-OF-WAY
(BETWEEN PROPERTY LINES EACH SIDE OF STREET)

1. Right-of-Way Opening or Pavement Cuts (CODE 104-13)

Table with 4 columns: Description, Amount, Unit, and Note. Rows include: 50 square foot or less (\$125.00), 51-100 square feet (\$270.00), 101-150 square feet (\$510.00), Over 150 square feet (\$1050.00), Trenches < 50 feet in length (Based on sq. feet as above), Trenches > 50 feet in length (\$340 + \$1.10 per linear ft.), *All trench excavations (\$200/week (inspection)), Anodes (\$10.00/Location), Anodes in pavement (\$125.00/Location). Note: ALWAYS.

2. Extended Maintenance Fee Reconstructed Street Excavation (CODE 104-20)

Table with 4 columns: Description, Amount, Unit, and Note. Rows include: 50 square feet or less (\$660.00), 51-100 square feet (\$1910.00), 101-150 square feet (\$3820.00), Over 150 square feet (\$6360.00), Trenches < 50 feet in length (Based on sq. feet as above), Trenches > 50 feet in length (\$1870 + \$11.00 per linear ft.). Note: PLUS, OR.

3. Extended Maintenance Fee Resurfaced Street Excavation (CODE 104-20)

Table with 4 columns: Description, Amount, Unit, and Note. Rows include: 50 square foot or less (\$330.00), 51-100 square feet (\$1020.00), 101-150 square feet (\$1800.00), Over 150 square feet (\$3600.00), Trenches < 50 feet in length (Based on sq. feet as above), Trenches > 50 feet in length (\$1010 + \$8.80 per linear ft.). Note: PLUS.

4. Street Reconstruction Cost Sharing (CODE 104-27)

Table with 2 columns: Description and Amount. Rows include: Heavy Duty Pavement (\$10.00 per square ft.), Medium Duty Pavement (\$8.00 per square ft.), Light Duty Pavement (\$6.00 per square ft.).

5. Driveway Permits (CODE 104-25)

Table with 2 columns: Description and Amount. Rows include: Resurface (Individual Driveway) (\$50.00), Resurface (Annual Fee) (\$260.00), Enlarging existing driveways/linear foot (\$35.00), Residential (maximum 15 ft.) (\$130.00), Commercial (maximum 30 ft.) (\$450.00).



6. Barricade or Obstruction Permits (CODE 104-24)

(Cranes) materials, scaffolding, barricades, etc)
Day \$50.00
Month \$360.00

7. Interference with Survey Monument per Occurrence (CODE 104-22)

\$400.00

8. Hauling Permit (CODE 104-23)

i.e. house moving; Within 3 weeks a new permit will be required to move
\$230.00 per move

9. Sidewalk Permits

(new or repair) \$35.00

10. Others

Erecting of new utility poles \$180.00 (CODE 104-13)
Installation of streets \$15.00/linear foot (CODE 104-15)
Annual Utility Maintenance Fees \$1430.00 (CODE 104-57)

11. Encroachments: City Code 104 – Article II

Annual Fees

Vaults & areaways (each)
100 square feet or less \$110.00 initially/\$35.00 annually
101-500 square feet \$230.00 initially/\$60.00 annually
Over 500 square feet \$340.00 initially/\$85.00 annually

Single Fees

Light fixtures (each) \$70.00
Storm enclosures (each) \$70.00 (6 months)
Marquees on buildings, etc. \$70.00
Flag poles \$70.00
Signs \$70.00 + bond or certificate of insurance
Entrance Details (steps and doors) \$70.00
Fixed or collapsible awnings \$70.00
Architectural details: air conditioners, grills,
eaves, sills, sun control devices, cornices \$70.00
Balconies and fire escapes \$340.00
Banners \$50.00 each/month
Fixed projections (architectural
Character) \$230.00
Building wall \$450.00
Tunnels between buildings (initially) \$230/\$120 annually
Bridges between buildings (minimum) \$230.00/\$35 annually
Sidewalk café \$120.00/8 months annual (April-Nov.)
(up to 3 tables/4 chairs per table; \$40.00 per each additional table/4 chairs)

11. Encroachments: City Code 104 – Article II

Footings	\$70.00 (104-34B2)
Foundation walls	\$70.00 (104-34B2)
Phone booth Installation	\$160.00 (104-24) annually

12. Permit to Cut Tree or Tree Branches Where Required for House Moving or Similar Instance

No permit charge
Actual cost payable by the utility (Forestry Division approval required)

13. Charge for Doing Work Without Obtaining a Permit and/or “Stop Work Order”

Double amount of applicable permit fee

14. Tests on Street Restorations

1 ST test	\$640.00	Plus permit cost
Additional tests	\$850.00	Plus permit cost

15. Extended Maintenance Fee

Resurface/rehabilitation	7 years
Reconstruction	15 years

16. Re-Inspections

\$80.00 per visit PLUS any other permit fees

17. Non-Specific Category (104-57A)

\$70.00

18. Overdimensional Vehicles (111-78)

Daily	\$230.00
Self-propelled rubber tired vehicles	\$680.00 Annual
Four (4) or more vehicles	\$2700.00 Annual
