What is redistricting?

- Rochester's City Council is comprised of
 4 District Members and 5 At-Large Members.
- The **4 District Seats** are subject to redistricting, which is based on decennial US Census data.
- Redistricting is the process of redrawing the lines of City Council's 4 Districts.





How is a district determined?

- Every 10 years, the US Census counts the city's population.
- The U.S. Supreme Court declared that equality of voting one person, one vote—means that "the weight and worth of the citizens' votes as nearly as is practicable must be the same."
- The principle of "one person, one vote" applies to Rochester City Council District Seats based on the Sanders decision.
- Note Although the above quote says "citizens" and mentions voting, district size is determined solely on population – it does not matter if those counted are citizens of the US, registered voters, etc.




How is a district determined?


- Under "one person, one vote" the total population of a jurisdiction is divided by the number of Districts within it – that number is considered the "ideal District population."
- Preferably, districts should not vary by more than +/- 3% of the ideal number.
- Adjustments to the Districts are made by moving smaller areas from one District to another.
- Historically, Rochester's 4 City Council Districts have been quadrant-based and have changed minimally every 10 years during the redistricting process.






Next Steps

- After these public input sessions, City Council will publish a report outlining all of the input received.
- A redistricting proposal will be submitted to the public and City Council after this report is published.
- After this legislation is proposed, City Council will seek additional comments from the community at a public hearing, and after receiving that citizen input, will act on the proposed plan.
- The new districts must be approved by City Council prior to 2023.
