 - Lydia: County Plan will be more focused on identifying streets and intersections that hold opportunities for walking and biking improvements
 - City will be more about aligning plans, filling gaps, and addressing approach to pedestrian safety, prioritization
 - County will be taking cues from us on anything that comes of this within the City from a physical perspective
 - Toole sharing data and engagement results internally
 - Some joint engagement activities
 - Monroe County DOT and Planning are stakeholders in our process; they have key roles to play in moving things forward in the City
- Evan (in the chat): suggestion for effective outreach, preceded by a question: are there resources beyond a raffle to incentivize the survey and other engagement needs/opportunities? I ask because... I worked for the City at the Public Market for 6 years, and many times organizations tried surveys at the Market because they knew the volume and diversity of attendees made it a great place to survey. I noticed that offering each person who completed the full survey a \$5 Market Gift Token exponentially expanded interest and involvement, and boosted number and diversity of responses! Raffle can be a decent incentive, but direct reward of \$5 Market Gift Token definitely boosted interest and taking surveys
 - Valerie (in the chat): great idea we always compensate with a stipend people we engage for their lived experience that we consider User/Experts.
 - Evan can connect us with the market very simple process for tabling, and can purchase tokens onsite
 - Example: U of R student wanted to learn more about diversity at the market, and offered the \$5 incentive to distribute a survey to learn about how many languages are spoken at the market on a given Saturday (final total was 70)
- Kevin: regarding the communities to reach, which is a great list many in the bike world have seen the graphic of the four types of transportation cyclists
 - There's only a certain percentage of folks who will likely make the change away from driving in our lifetime
 - o Should focus on the folks that are interested but concerned
 - o Applies as an overarching lens to the entire communities to reach list
- Kevin: make a significant connection to the Rochester 2034 plan
 - Recommendations should be called out specifically and built upon
 - Rochester 2034 moving forward logo
 - Incorporate principles
- Rashad: Evan, do you know of any other outlets for providing incentives like this? Mobile food trucks, etc?
 - FoodLink Curbside Markets, mobile food vans that go largely to public housing communities;
 could work with them to accomplish something similar
