Vendors with prepared foods must also provide a **physical copy of a City of Rochester Vending Permit, and Physical Copy of Tax ID, OR a Monroe County Health Certificate, Tax ID, Fire Safety Inspection Certificate, proof of Insurance \$ 1,000,000.00 (naming the City of Rochester as additional insured), a photo of vehicle (including length) and copy of proposed menu.** *Note: A tax Id is not about sales tax, it's about what you use for reporting your income on your income tax, ex: Social Security card, NYS Tax Certificate or Federal EIN letter.

- D. Vendors are prohibited from hawking, shouting, using music etc., to attract customers.
