Section 1. The Mayor is hereby authorized to enter into a professional services agreement with CypherWorx, Inc. in the maximum amount of \$134,306 to provide an online training platform for City employees. The term of the agreement shall be three years with the option to extend for one additional period of three years. The agreement shall be funded in the amount of \$44,736 from the 2022-23 Budget of Undistributed Expenses (Undistributed), \$44,736 from the 2023-24 Budget of Undistributed and \$44,834 from the 2024-25 Budget of Undistributed, contingent upon approval of the two latter budgets.

Authorizing an agreement providing City internships to SUNY Brockport students

BE IT ORDAINED, by the Council of the City of Rochester as follows:

Section 1. The Mayor is hereby authorized to enter into an agreement with The College at Brockport, State University of New York (SUNY Brockport) to engage up to five SUNY Brockport students as interns working for the City of Rochester. The term of the agreement shall be one year, with the option to extend for up to two additional 1-year periods. The compensation for each intern shall be paid by SUNY Brockport through the federal Community Service Work-Study Program and the City shall reimburse SUNY Brockport for 25% of each intern's compensation up to an annual limit of \$1,125. The City's total internship reimbursements in an annual amount not exceeding \$6,000 shall be funded from the 2022-23 Budget of the Office of the Mayor for the initial term, and from a future year's Budget of the Office of the Mayor for each extended term, contingent upon approval of said future budget.

Section 2. The agreement shall contain such additional terms and conditions as the Mayor deems appropriate.



Establishing an Opioid Compensation Fund

BE IT ORDAINED, by the Council of the City of Rochester as follows:

Section 1. Chapter 8 of the Municipal Code, Department of Finance, as amended, is hereby further amended by adding § 8.5 as follows:

§ 8.5 Opioid Compensation Fund.

A. As used herein, the following terms shall have the following meanings:

OPIOID COMPENSATION

Funds granted to the City pursuant to the settlement of or verdict or judgment in an Opioid Litigation.

OPIOID LITIGATION

Any action or claim brought by the City, the County of Monroe, or the New York State Attorney General against manufacturers, distributors, or pharmacies that have sold or distributed opioids in the City of Rochester and alleging that such manufacturers', distributors', or pharmacies' conduct constitute or have constituted a public nuisance or other tort.

B. A special revenue fund, the Opioid Compensation Fund, is hereby established for the deposit of all Opioid Compensation collected by the City. The Opioid Compensation Fund shall consist of two accounts:

1. The Restricted Account, for Opioid Compensation that is restricted to certain approved uses set forth in the terms of the settlement, verdict, award determination or other document authorizing the payment of Opioid Compensation. Such approved uses may include, but are not limited to, programs and activities for preventing and treating opioid use disorder, for the care and recovery of those who suffer from opioid use disorder, and for the support and education of first responders, health care providers, and family members who care for them. The Director of Finance shall keep a record of the use restrictions for each payment of Opioid Compensation into the Restricted Account.
2. The Unrestricted Account, for Opioid Compensation that is not restricted to specific uses.

Section 2. This ordinance shall take effect immediately.

Authorizing a lease for space located at 1099 Jay Street

BE IT ORDAINED, by the Council of the City of Rochester as follows:

Section 1. The City is hereby authorized to enter into an agreement with Rochester Colonial Mfg. Corp. for the lease of approximately 3,190 square feet of floor space at 1099 Jay Street for municipal use. The term of the agreement shall commence on a mutually agreed upon date from October 1, 2022 to November 1, 2022 and shall extend to June 30, 2024, with the option to extend for up to five additional periods of 1 year each.

Section 2. The rent payments shall be \$2,791.25 per month for the initial term. The rent payments shall be funded from the 2022-23 Budget of the Rochester Police Department (RPD) for the initial term, and from the future years' Budgets of RPD for each optional term extension, contingent upon the approval of the future budgets.

The sum of \$240,510 is hereby appropriated from the Emergency Solutions Grant-Coronavirus (ESG-CV) allocation of the Consolidated Community Development Plan/2019-20 Annual Action Plan as amended by Ordinance No. 2020-130 and by Ordinance No. 2020-225 to continue and expand services for the homeless and those at risk of homelessness under the Emergency Solutions Grant Program.

Section 2. The Mayor is hereby authorized to enter into a professional services agreement with Person Centered Housing Options Inc. to provide street outreach and engagement services for homeless and unhoused persons with a focus on oversight of the Peace Village homeless camp and outreach to the surrounding areas. The maximum compensation for the agreement shall be \$250,000, which shall be funded in the amounts of \$240,510 from the ESG-CV funds appropriated in Section 1 herein and \$9,490 from ESG-CV funds appropriated to services for the homeless and those at risk of homelessness in Ordinance No. 2020-188. The agreement shall have a term of 1 year with the option to extend for up to one additional year if funds from the original appropriations remain.

Authorizing an application and grant agreement for Restore NY Communities Initiative - Round 6

WHEREAS, the Mayor has presented to the Council of the City of Rochester a proposal to submit an application to the Empire State Development Corporation (ESD) and to enter into a subsequent agreement with the New York State Urban Development Corporation, doing business as ESD, for the receipt and use of a grant of up to \$5 million through Round 6 of the Restore NY Communities Initiative (Restore NY), for the City to provide gap funding for the adaptive reuse and/or rehabilitation of Rochester Riverway-Downtown East Initiative properties identified as strategically important to the continued revitalization of the Center City (the Project); and

WHEREAS, the Council has conducted a duly noticed public hearing and reviewed the Project that is proposed for the application to ESD in accordance with Restore NY program requirements and guidelines.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of Rochester as follows:

Section 1. The Council hereby finds that:

(a) the proposed Project is consistent with the following principles:

- 1) the Comprehensive Plan;
- 2) the Consolidated Community Development Plan for 2020-2024;
- 3) the Center City Master Plan;
- 4) the Housing Policy; and
- 5) the Midtown Urban Renewal District Plan;

(b) the proposed financing is appropriate for the Project;

(c) the Project will facilitate effective and efficient use of existing and future public resources so as to promote both economic development and preservation of community resources; and

(d) where applicable, the Project develops and enhances infrastructure and/or other facilities in a manner that will attract, create, and sustain employment opportunities.

Section 2. The Mayor is hereby authorized to submit the Project application to the Empire State Development Corporation (ESD) and to enter into a subsequent agreement with the New York State Urban Development Corporation, doing business as ESD, for the receipt and use of a grant of up to \$5 million through Round 6 of the Restore NY initiative, to provide gap funding for the adaptive reuse and/or rehabilitation of the Rochester Riverway-Downtown East Initiative properties identified as strategically important to the continued revitalization of the Center City (the Project).

Section 3. The application and agreement shall contain such terms and conditions as the Mayor deems appropriate.

The City of Rochester, in the County of Monroe, New York (herein called "City") is hereby authorized to finance the costs of acquiring body worn camera equipment and of designing and implementing a digital evidence management system for the Rochester Police Department (the "Project"). The estimated maximum cost of said class of objects or purposes, including preliminary costs and costs incidental thereto and the financing thereof, is \$3,834,455.85. The plan of financing includes the issuance of \$2,020,000, which amount is hereby appropriated therefor, \$370,000 in 2020-21 Cash Capital, \$1,025,000 in 2022-23 Cash Capital, \$419,455.85 from the 2022-23 Budget of the Police Department and the levy and collection of taxes on all the taxable real property in the City to pay the principal of said bonds and the interest thereon as the same shall become due and payable.

Section 2. Bonds of the City in the principal amount of \$2,020,000 are hereby authorized to be issued pursuant to the Constitution and laws of the State of New York, including the provisions of the Local Finance Law, constituting Chapter 33-a of the

Consolidated Laws of the State of New York (herein called the "Law"), this Ordinance, and other proceedings and determinations related thereto.

Section 3. The City intends to finance, on an interim basis, the costs or a portion of the costs of said improvements for which bonds are herein authorized, which costs are reasonably expected to be reimbursed with the proceeds of debt to be incurred by the City, pursuant to this Ordinance, in the amount of \$2,020,000. This Ordinance is a declaration of official intent adopted pursuant to the requirements of Treasury Regulation Section 1.150-2.

Section 4. The period of probable usefulness of said class of objects or purposes described in Section 1 of this Ordinance, within the limitations of 11.00 a. 32.of the Law, is five (5) years.

WHEREAS, New York State Civil Service Law Section 50 authorizes municipal civil service commissions, subject to the approval of the municipal legislature, to establish, waive, or abolish fees for civil service examinations, and

WHEREAS, Chapter 14-11 of the Municipal Code of the City of Rochester authorizes the City of Rochester Municipal Civil Service Commission to adopt rules and regulations to provide for waivers of examination fees where such waiver is deemed to be in the best interest of the City, and

WHEREAS, the Mayor of the City of Rochester and the County Executive of the County of Monroe created a Commission on Racial and Structural Equity (RASE Commission) to assess laws and policies that promote or eliminate institutional and structural biases, racism, or inequities, and to recommend changes to address such issues, and

WHEREAS, the RASE Commission recommended that the City of Rochester and the County of Monroe eliminate civil service examination fees for all open-competitive civil service examinations in order to eliminate barriers to employment for marginalized communities, and

WHEREAS, the City of Rochester Municipal Civil Service Commission, on August 25, 2022, adopted Resolution No. 2022-08-23, to waive civil service examination fees for a period of thirteen months beginning on July 1, 2022, and to evaluate the effects of such policy and whether to renew it, and

WHEREAS, pursuant to Section 50 of the New York State Civil Service Law, such waiver is subject to the approval of the governing board or body of the City

NOW THEREFORE, BE IT RESOLVED, by the Council of the City of Rochester as follows:
